In this past year, our city has been hit by major flooding three times and counting, and several impoverished neighborhoods have been hit more than once.

Most of us can survive the challenge of a flooded home, a sudden job loss or a serious illness because we have back-up resources – savings, insurance, a second income or family who can help. But for the most vulnerable individuals and families in our city, one crisis can be devastating.

Since the most recent floods, our staff members have worked tirelessly, often at night and on weekends, to help meet the needs of families displaced from local apartments. Their goal is to help people get back to normal,

sustainable life as soon as possible, but it's an uphill climb when they're starting with nothing. I am consistently impressed by how caring our Catholic Charities team members are, how well they listen and how persistently they help people connect to resources so they can get their lives moving forward again.

In just the first two weeks after the flood, a small Catholic Charities team put in an extra 1,200 hours to personally check on and assist displaced families. I am grateful to them, and I am especially grateful to those of you who provided funds to allow us to give them grocery and gas cards, to help pay rent and utilities, and to pay for desperately needed hotel rooms.

Together, we are the back-up resources for people who aren't

fortunate enough to have any. Whether they're hit by a flood or some other life-altering challenge, they count on us to be there.

Thank you for your help toward providing help and creating hope when families need us most.

The staff has since assisted many in the Greenspoint area of Houston with basic needs assistance, clothing and furniture vouchers for the St. Vincent de Paul thrift store, food pantry assistance and counseling.

The Catholic Charities staff is providing case management and advocacy for displaced people, helping them connect to resources and figure out how to get their lives back to normal.

"We are thankful to everyone who has contributed funds, as well as time and prayers," said Cynthia N. Colbert, MSW, president and CEO. "Unfortunately, our work is not over yet. Our neighbors



are still reeling from the multiple floods and can use our continued service and support."
